Payments can be paid either by:

- SLS Members Portal - Login (username/password) - Due to the facelift of the SLSA Members Area – you will be required to do a password reset – follow the prompts
- Click Memberships tab - Click Renewals, Payments tab - **Click Renew**
- **Update any personal details** then press submit before **proceeding** to online payment
- Ensure Club/Organisation is **Ulverstone SLSC** and **Transaction type is Membership fee**
- In payment details include names of all family members you are paying for.
- Type in amount for the transaction - Proceed to payment details – fill in

or

- **Directly** to Club Registrar Ann Eustace
